Audit Process

- Interviews and review of documents
- Automated and manual review of department websites



Audit Process

- Write final audit report
- Obtain department response
- Issue report and brief interested parties



Departments and Websites Reviewed For This Audit

We reviewed four state entities and web based services they offer to determine compliance with web accessibility standards and whether any violations of those standards on each departments' website would prevent a person with disabilities from completing a core task online.

Audit Results – Website Compliance

- We found the websites we reviewed were not fully compliant with the web accessibility standards that California requires
- All four websites had web accessibility issues that our consultant considered critical
- Some violations were distinct and some were common



Audit Results – Website Compliance

Department	Critical Distinct Violations	Critical Common Violations
Community Colleges	26	2
CalHR	26	7
Covered California	287	18
Franchise Tax Board	17	7



Audit Results – Burdensome Violations

- Some website compliance violations we found would stop a person with disabilities from being able to complete a crucial task online
- We found this type of violation at three departments:
 - ✓ Community Colleges
 - ✓ Covered California
 - ✓ Franchise Tax Board



Audit Results – Accessibility Testing

- Three of four departments initially tested for accessibility before their website was public
- However, those same three departments did not conduct regular accessibility tests when their websites were updated
- Franchise Tax Board did not conduct accessibility testing on CalFile before it was released, but has completed tests annually since 2012

Audit Results – Statewide Recommendations

 We made some recommendations directly to the departments we audited

 There were also several recommendations that, if implemented, would have statewide impact



Audit Results – Statewide Recommendations

- The Legislature should name the California Department of Technology as the lead agency responsible for providing state employees training on website accessibility
- The Legislature should require governmental entities to provide or obtain website accessibility training for their employees



Audit Results – Statewide Recommendations

 The Department of Technology should issue a policy that describes the methods by which state departments should conduct web accessibility testing



Audit Recommendations – Follow Up

 Since we issued this report, the departments we audited have made progress in addressing our recommendations

 All four departments have begun fixing the specific accessibility violations that we found during our review



Audit Recommendations – Follow Up

All but one burdensome violation has already been addressed

 CalHR and Community Colleges have implemented formal accessibility testing plans
